PLANTING TREES

In the autumn issue we asked for views about where we should plant a tree to replace the one lost from the village green. Following the November Parish Council meeting and further discussion, we are planting two silver birch in the cemetery; some trees in the Parish Field; and, in February, will be planting a tree donated by West Lindsey District Council on the village green to celebrate the Queen's Platinum Jubilee.

Stow Recreation Fund Update

If you have been down Stow Park Road in the last few weeks you will have seen that the final bench has now been installed. For those of you asking why it is facing the way it is – the residents' poll, which was publicized here in the Bugle, and on the village Facebook page, received 21 votes, 11 for South facing towards Sturton and 10 for North facing towards Willingham. It is hoped it will be a welcome resting spot for those out walking. Would anyone like to offer to be responsible for cleaning that bench? We have a group of volunteers who already wipe the Green Lane bench and those in the playpark and cemetery, but a new volunteer for this bench would be great.

The CPR and defib training sessions held by LIVES at St Mary's in December were very well received and it was great to see so many residents taking part and benefiting from the free advice and demonstrations. Hopefully the defib will not be needed too often but it is comforting to know that so many of you will have the confidence to use it, or direct others.

Further to the article in the Autumn Bugle about a public meeting to sanction the winding up of the Fund when all of the projects are completed, the village signs are still not yet completed. We hope that a few issues with bringing parts of the design to fruition on the metal will be resolved very soon, so that we can chase the contractor to confirm a date for them to be installed on the verges. Meanwhile we are unable to organise a definite date for the public meeting. Monday 21st March at 7.30pm has been pencilled in, but more information and the report to residents will be circulated via the Bugle or village email list nearer the time. As no one responded to the original article requesting an 'in person' meeting, it is currently intended to be by way of Zoom, with joining details provided to all those who express an interest.

NEIGHBOURHOOD PLANNING GROUP



The Independent Examiner appointed by West Lindsey District Council (WLDC) is now considering our draft Neighbourhood Plan.

He commenced his examination on 17th January. This stage should be completed by 17th March, but he is aiming for a five week completion. This will involve negotiation on any contentious points and then he will identify changes we need to make.

Once completed, it will not be too long before the Plan will go out to referendum in Sturton by Stow and Stow parishes.

The Parish Council has responsibility for a wide range of local issues, for example:

- Maintenance of the village playpark, which includes funding an annual health and safety inspection
- Cataloguing, mapping and registering with the Land Registry all the land that the Parish owns or has responsibility for.
- Maintenance of Stow civil cemetery
- Maintenance of grass and trees on Parish owned land
- Taking a view on planning applications submitted to West Lindsey District Council and submitting that view to WLDC.
- Preparation of the Joint Neighbourhood Plan with Sturton.

The Council operates on a tight budget, but tries to gauge local needs and work with the District and County Councils to fulfil them. We report faults such as damaged highways signs, drains, furniture, though villagers can report such things directly. The Council endeavour to work with the Highways department with regard to improvements such as speed management and road safety.

The Council has also in the past funded the purchase of the Christmas tree by Doug Garner, who also organises its decoration. The Council has also received grants to provide facilities for the parish such as benches, speed management and the village signs.

In order to fund the above and any other expenditure, the Council receives what is called a Precept. This is an amount of money included in the Council Tax we all pay. The Precept for 2022/23 will be £5000.

There is an annual Parish Meeting in May, which all residents are welcome to attend. The Parish Council meets every two months, but between meetings conducts business by email, phone and in person.

In March 2021 the Parish Council adopted a number of **objectives**:

- 1. Keep the precept as low as we can whilst continuing to provide an appropriate level of services. ✓
- 2. Complete the Neighbourhood Plan, and propose it for acceptance in a referendum of those eligible to vote on it. It is currently with the Independent Examiner.
- 3. Review the 'Community Aspirations' in the Neighbourhood Plan, make plans for fulfilling those that we are able to, and publish explanations for those, which we are unable to. *Yet to be done*.
- 4. Appoint individuals to monitor various areas of SPC's responsibilities, develop proposals and draw SPC's attention to the need for action when necessary. By doing this, expand the participation of parishioners in SPC's activities. *In part*.

- 5. Monitor performance of the service provision to the Parish by local authority service providers, and take action to improve same as appropriate. Have worked closely with Highways on a number of issues. (Likewise with Acis). Further work needed with Northern Power and Anglian Water.
- 6. Establish the extent of land ownership by SPC, and grey areas. Create a plan for resolving the grey areas. *David Justham has done detailed work on behalf of the Parish Council, which will enable registration as it can be funded. Our thanks to David.*
- 7. Form a plan for the use of the space and renewal of the Playground equipment with input from parents and children, and renew those items for which we have the funds. *The large piece of equipment has been replaced and is proving popular. There are some smaller pieces, which require replacement.*
- 8. Expand the use of digital communication between SPC and Parishioners. The Bugle is issued for special items eg the solar farm proposals as well as on a regular basis. Facebook is also increasingly used.
- 9. Conduct our own activities, and respond to planning consultations, in line with the relevant aspects of the Neighbourhood Plan. ✓
- 10. Issue 'The Bugle' newsletter approximately 4 times per year. ✔

It was appreciated that realising these objectives would take some time, and that the Council may need continued and/or additional support from parishioners to do so.

Are you the person to come and join us to help meet these objectives or do you have ideas of what the council could or should be doing and want to have a go?

There will be a vacancy on the council for the year 2022/23. If you are interested and want to know more about what is involved contact the Parish Clerk stowparishclerk@gmail.com. or one of the councillors.

To be a councillor you must be: British or a citizen of the Commonwealth, at least 18 years old, registered to vote in the area or have lived, worked or owned property here for at least 12 months before the election.

Update from Cottam Solar Power Project

"We are writing to provide you with an update on next steps for the Cottam Solar Project and West Burton Solar Project.

In December we concluded our phase one consultation on early-stage proposals for the projects. The aim was to:

- 1. introduce ourselves and share an early overview of the projects;
- 2. receive initial feedback from the community, which alongside our technical assessments will help us to better understand any potential environmental impacts and be used to help us develop the detail of our proposals; and
- 3. begin to identify opportunities for these projects to benefit the local community.

All feedback has been logged and we are taking the time to consider the comments received as we develop our proposals further. Alongside this we are also undertaking a full Environmental Impact Assessment (EIA) for the Cottam Solar Project and the West Burton Solar Project.

As you may be aware, EIA is a detailed process to study likely environmental effects by carrying out surveys to establish the environmental impacts of the projects, and identify mitigation measures where required. The EIA will inform our design for the layout, appearance, and operation of each project, but importantly, also provide answers to the many detailed questions raised by members of the local community and other stakeholders during our initial phase one consultation.

We will soon be submitting an EIA Scoping Report for each solar project to the Planning Inspectorate (PINS). These will provide background environmental information and set out the parameters for the construction and operation of each project. Upon receipt of our EIA Scoping Report, PINS will consult on the contents of the report with statutory consultees including parish councils. Any responses to the Scoping Report will need to be sent directly to PINS, and PINS will determine what should be the scope of the EIA.

Our phase two consultation, which will be a statutory consultation this summer, will include sharing the findings of our Preliminary Environmental Information Report (PEIR), alongside more detailed design information on the proposed layout, appearance, and operation of the solar projects. At that stage we will also be seeking further feedback from both the local community and statutory consultees on the detailed environmental information measures presented in the PEIR, and the mitigation measures proposed.

Our full Environmental Statement, detailing the outcome of our completed EIA and the mitigation measures proposed, will be submitted to PINS for public examination as part of the final Development Consent Order (DCO) application for each project. A Consultation Report will detail all the feedback we have received throughout the consultation process and how consideration of this has influenced the final proposals we have submitted. FLY TIPPING

Every so often there are problems with fly tipping. If you see some fly tipping on roadsides you can report it to WLDC. Please note: If the fly tipping is situated on privately owned land (owned by individuals, businesses etc), WLDC are not able to remove it. It is the landowner's responsibility to remove any rubbish, so if you know who that is, you may wish to bring it to their attention. If it is not cleared after 28 days, please contact WLDC as they may be able to take enforcement action to resolve the problem.

For WLDC it is important to build up an accurate picture of problems in the area. Where there is evidence to identify where the fly tipping has come from, they will investigate and prosecute if possible.

STREET NAMES

A list of street nameplates that require replacing is being drawn up for those that are rotten, damaged or faded. WLDC are asking residents to look out for nameplates that may need replacing.

Right Thing, Right Bin - recycling advice:

As part of our 'Right Thing, Right Bin' campaign, WLDC have been working alongside Lincolnshire Recycles to ensure that residents are maximising their recycling and using their blue bin correctly to avoid contamination, until their purple-lidded bin arrives in the Spring.

We are continuing to remind residents they should use their blue recycling bin for all of the following items and they should be clean, dry, loose and squashed within their bin and not contained within bags:

- Glass bottles and jars
- Metal items drink cans, food tins, biscuit and sweet tins, empty aerosols and clean aluminium foil
- Plastic packaging all plastic bottles, pots, tubs and food trays, with the exception of black or brown ready meal food trays and plant pots
- Paper and cardboard (although no shredded paper, tissues/kitchen roll or anything with glitter on)

Calendars for dates of the first separate paper and card collection using the purple-lidded bin will be arriving to residents shortly. Once these collections start, we will no longer accept paper and card in blue bins.
